#### **Opportunity for Public Input:**

Sue and Bob Stiger introduced the River Friends 2019 organization, expressing river residents' concerns over large wakes and sharing orgs history of interaction with the County Commissioners and Water Ways Advisory Board. Shared Sheriff's proposed rules amendment. Requested that the RiverFriends and HLWID share information on issues of common interest. SM expressed the District's interest and approved continuing interactions with RF.

#### **HLWAI Updates**

- Continue to work on no wake corridor issue
- Sherriff's candidate forum in April at Country Club
- No-wake ordinance being proposed for Honeysuckle Bay by Healy and Hathaway; some expectation that HLWID will pay for the buoys
- Has analyzed three years of data and seen NH3 spikes; clearly making a case that the North Arm is very different wrt nutrients; writing a report
- Geoff's book, Hayden Lake Primmer is published in KDP format and on Amazon

#### **Old Business**

- Buoy MOU w County indeterminant situation on the count i.e. we have permitted 14; the
  advocacy for 7 has died away; there is a process for adding more; the memo circulated
  summarizing the process articulated 14 at the locations discussed; we can assume that the 14
  buoys
- Liability insurance wrt buoys; SM has solicited info from John Getty, awaiting response

#### **New Business**

- Discussion can we stop publishing payables on the meeting agenda? See Stephanie's message dated 10/16/19. StMu
  - LN moved to stop publishing in agenda and attach approval report to minutes; PL second; all approved
- Discussion how to have a trained and dedicated Marine Sheriff for HL? LN without enforcement, the buoy installation will not be effective; Sheriff supports potential plans for enforcement; 42K\$ for full-time year-round salary, can we afford a part-time 3-month person? Possibly set a person up with a light on the boat and a uniform t-shirt to take photos. No next-steps identified
- Discussion should we investigate the cost and logistics associated with the development and installation of signs at the public ramps and marina notifying the public of the no wake laws – LN
