- Nov through Jan activities
  - Pursued issues re non-permitted construction with the Highway District and Kootenai County. These construction activities have a potentially detrimental impact on Hayden Lake: 266 E Hayden Lake Rd, 5700 E Hayden Lake Rd, and Evernade. The County has been slow to respond. The HLW Association plans to take up this issue.

HLWAI activities – did not meet in December; see

#### **Old Business**

- Honeysuckle Bay designated no-wake-zone:
  - From 11/18/19 SM communicate HLWID's support for Craig Ely's plan to the County P&W - this needs to be formally done
  - Ely sent proposal via GH; he did send it to the county; drawing reflect agreed-upon zone boundaries, number of buoys in question;
  - Board confirmed that they would fund 3 buoys in addition to the 14 approved (permitting will be required).
  - o LN to submit RFP for buoy purchase and placement
- No-wake signs at boat ramps LN no real changes: City of Hayden postponed discussion on consent calendar until next meeting; Sportsman's kiosk looks OK; Hayden Lake Marina still outstanding
- Waterways Advisory Board (WAB) workshop outcomes
  - O GH Dec meeting: primarily sheriff's proposal for boater education and for 200 ft NWZ, WAB passed motion to forward this as proposed onto commissioners; Jan 7<sup>th</sup> workshop: participants stated their positions wrt wakes; association's position was to apply 200ft NWZ to all county waterways and add 500 ft. limit for wake-producing boats when in wake-producing mode; WAB took it under advisement until Feb 19<sup>th</sup> meeting

#### **New Business**

- Review North Arm Water Quality and South Shore Runoff study reports
  - From 11/18/19 GH check feasibility of reducing frequency of North Arm water testing

     preliminary conclusion is that the North Arm testing should be shifted to Mokins and
     O'Rourk Bays.
